

## WHAT YOU NEED TO KNOW ABOUT OVERDRAFTS AND OVERDRAFT FEES

An overdraft occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. We can cover your overdrafts in two different ways:

1. We have standard overdraft practices that come with your account.
2. We also offer overdraft protection plans, such as a sweep from another account which may be less costly than our standard overdraft practices. To learn more, ask us about these plans.

This notice explains our standard overdraft practices.

➤ **What are the standard overdraft practices that come with my account?**

We do authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number
- Automatic bill payments

We will not authorize and pay overdrafts for the following types of transactions without your consent.

- ATM transactions
- Everyday debit card transactions

**We pay overdrafts at our discretion**, which means we **do not guarantee** that we will always authorize and pay any type of transaction. **If we do not authorize and pay an overdraft, your transaction will be declined.**

➤ **What fees will I be charged if Town-Country United Bank pays my overdraft?**

Under our standard overdraft practices:

- We will charge you a fee of up to **\$25** each time we pay an overdraft if your account is overdrawn more than \$10.
- We will not charge a fee if the transaction is \$10 or less that causes an overdraft or if your balance is overdrawn by \$10 or less.
- If your account is overdrawn for 3 or more consecutive business days, we will charge an additional \$1 for each of the consecutive business days the account remains overdrawn
- There is a limit of \$100 per day on the total fees we can charge you for overdrawing your account

➤ **What if I want Town-Country United Bank to authorize and pay overdrafts on my ATM and everyday debit card transactions?**
